The primary objective of the European directive 'MiFID' (Markets in Financial Instruments Directive) is an enhanced consumer protection in respect of financial products and services.

This European directive provides for a number of rules of conduct applicable to financial service providers.

These rules of conduct are aimed to achieve a better transparency of these products and services for the consumer.

The Belgian legislator partially integrated this directive into insurance legislation, known as Twin Peaks II, Act of 30 July 2013, supplemented by three Royal Decrees of 21st February 2014. The FSMA Circular of 16th April 2014 supplements this legislation and clarifies it. This Circular entered into force on 30th April 2014.

As independent insurance brokers, the assured is our main concern. Havrico Insurance have always aimed to duly advise and inform its clients in a clear and correct way.
